

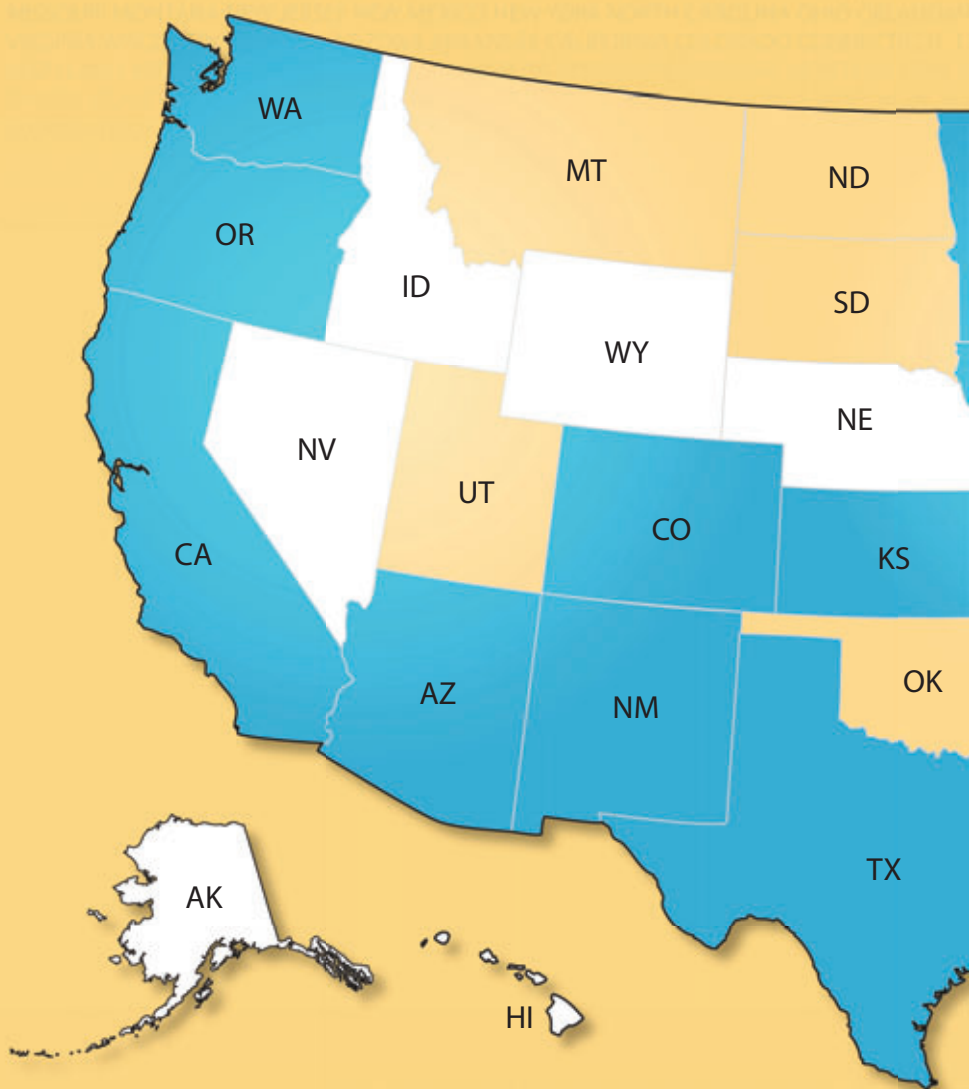

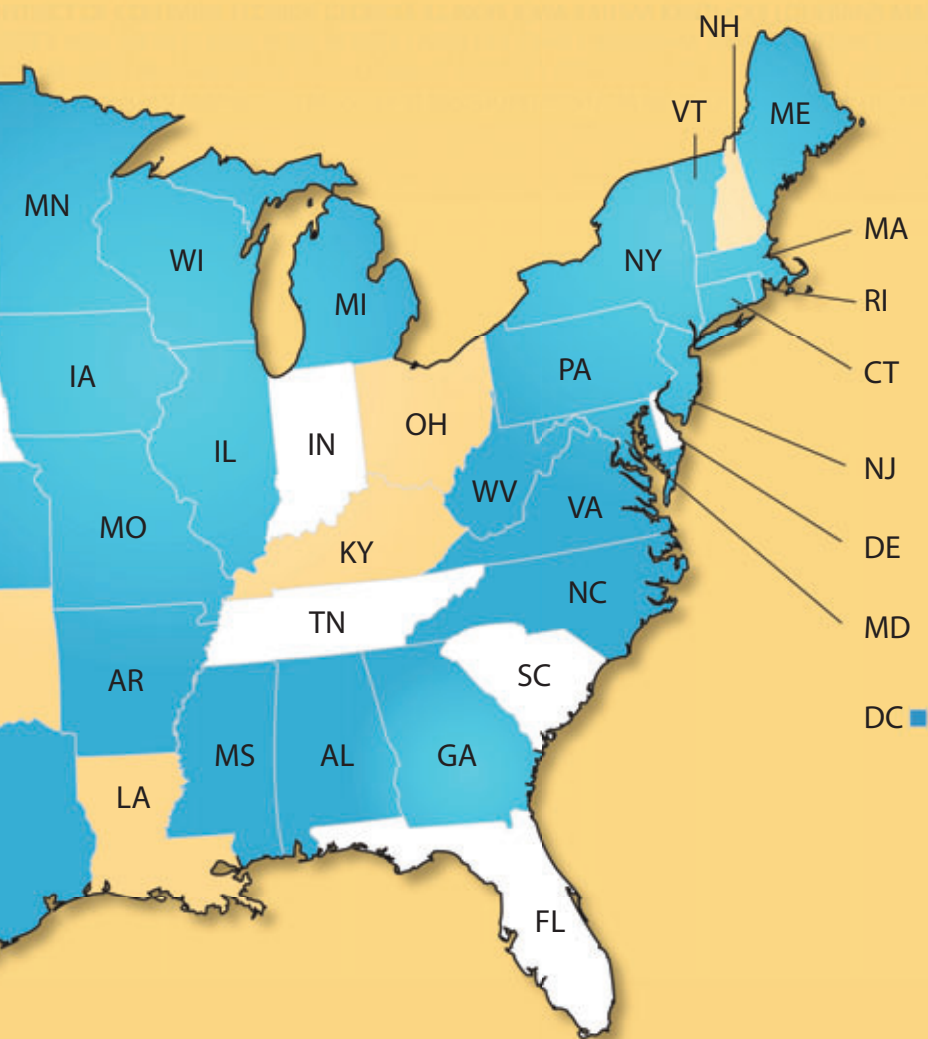
A Growing Network

SFAI goals

Improve State Tax and Budgeting Systems

States need to raise adequate revenue in a fair, responsible, and sustainable manner in order to meet critical responsibilities such as education, public safety, and health care.



SFAI organizations analyze major tax proposals and develop and promote options to make tax systems better. They also assess how proposed changes in federal policies would affect state finances.

SFAI groups make sure policymakers and the public understand the implications of arbitrary spending limits and other budget gimmicks. And they identify long-term strategies for sound state budgets and strong state economies.

Strengthen Policies for Low-And Moderate-Income Families

SFAI groups work at the state level to improve economic security and opportunity. They do so by analyzing the barriers that can prevent low-income families from improving their lives and by identifying sound policy solutions, like fairer tax systems, better health care, affordable child care, work supports, and income assistance.



Expand Public Debates over Budget Issues

The budget is a state's single most powerful decision-making tool. But too often budgets are written and debated in terms that most citizens (and even many policymakers) cannot understand. SFAI groups provide the translation. They analyze budget trends and options to make clear the crucial choices that states face.

By widely disseminating their work and interacting with the news media, SFAI groups shape the debate and make it accessible to advocates and the public.



Making a Difference on State Fiscal Policies

SFAI groups shape budget and policy outcomes by providing reliable, timely, and accessible research to policymakers, the media, advocates, and the general public.

SFAI groups also conduct presentations and training on budget issues for anti-hunger organizations, business and professional groups, children's advocates, churches, community organizers, environmental advocates, labor unions, local governments, social service providers, service clubs...and many more.

Reliable

Timely

To maximize their impact on budget and tax policies, SFAI groups issue analyses at the same time policymakers are debating key issues.



Accessible

Tax and budget information often appears complex. This can discourage the public — and even some policymakers — from paying attention to these issues. SFAI materials are written in plain language that policymakers, the media, and the public can understand.
